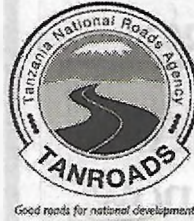

Invitation for Bids

**CONSTRUCTION OF MSALATO INTERNATIONAL AIRPORT – PHASE ONE,
LOT 1, PACKAGE 2: BUILDINGS**

1. The Government of United the Republic of Tanzania has received financing from the African Development Bank (AfDB) towards the cost of the **Construction of Msalato International Airport – Phase 1, Lot 1**, and intends to apply a portion of these funds to cover eligible payments under the Works Contract for the **Construction of Msalato International Airport – Phase 1, Lot 1, Package 2: Buildings, Tender No. AE/001/2019-20/HQ/W/39**.
2. The Tanzania National Roads Agency (TANROADS), an Agency of the Ministry of Works, Transport and Communication hereinafter referred to as the Employer now invites sealed bids from eligible and qualified bidders for **Construction of Msalato International Airport – Phase 1, Lot 1, Package 2: Buildings, Tender No. AE/001/2019-20/HQ/W/39**.
3. The estimated quantities for major items of works are as follows:

4. Bidders should note that to qualify for award of the contract, they are required to meet certain minimum qualifying criteria. It should be noted that Bidders must be able to demonstrate that, in the capacity as a prime Contractor, they should have successfully completed at least **three (3) projects** of similar nature, each with a value of at least **US\$ 80,000,000.00** within the last **ten (10) years**. Bidders are required to provide full and detailed particulars of their financial capability to perform such works and to demonstrate that they have experienced key personnel with appropriate qualifications. As part of proof of experience on **Construction of Airport Buildings projects**, Bidders are required to submit certified forms of Contract for awarded Contracts in the past, Taking Over and Completion Certificates duly certified together with Telephone Number and e-mail addresses of the previous Employer/Awarding Agency. Bidders should also note that the works must be completed within **Thirty-Six (36) months inclusive of three (3) months of mobilization** and that they are required to provide detailed particulars of all items of equipment and plant that they deem necessary to deploy for the timely completion of the works. **Bidders who are proven non-performers need not apply as they will be disqualified.**

5. Interested eligible Bidders may obtain further information and inspect the bidding documents at the office of **The Secretary, TANROADS Headquarters Tender Board, 2nd Floor, 10 Shaaban Robert Road/Garden Avenue Junction, Dar es Salaam** from **8:00 hours to 16.30 hours** local time, Mondays to Fridays inclusive, except on Public Holidays.

6. A complete set of Bidding Documents may be purchased by interested bidders upon submission of a written application to the above address and upon payment of a non-refundable fee of **Tanzania Shillings Three Hundred Thousand Only (TZS 300,000)** which has to be paid with reference to **Government's e-Payment Gateway System (GePG)** Control Number to be issued by the Accounts Section at TANROADS Headquarters.

Bidders can collect the Bidding documents from 08:00 hours to 16:30 hours local time from Monday to Friday inclusive, except on public holidays at the Employer's Head office in Dar es Salaam. Documents will not be dispatched by Courier Service.

7. Bids shall be valid for a period of **120 days** after Tender opening, and must be accompanied by a "Bid Security" in original and in an acceptable form in the amount of **TZS 1,000,000,000 (Tanzania Shillings One Billion Only)** or its equivalent in a freely convertible currency and the bid must be submitted or be sent by a registered post to: **The Secretary, TANROADS Headquarters Tender Board, 2nd Floor, 10 Shaaban Robert Road/Garden Avenue Junction, Dar es Salaam, P.O. Box 11364, Dar es Salaam, TANZANIA** so as to reach him on or before the deadline for submission of bids.

The Bid Security shall be clearly addressed to: **The Chief Executive, TANROADS, P. O. Box 11364, Dar es Salaam.** The Tender Security shall be valid for **Twenty-eight days (28)** beyond the end of the validity of the bid.

8. Bids will be opened in the presence of Bidders' representatives who choose to attend, immediately after **10.00 hours local time, on 29th April 2020**, at **TANROADS Conference Room, 2nd Floor, TANROADS Headquarters, 10 Shaaban Robert Road/Garden Avenue Junction, Dar es Salaam**, immediately after submission deadline and in the presence of Tenderers' representatives who choose to attend.

The outer cover of the Bids must be clearly marked "**Construction of Msalato International Airport – Phase 1, Lot 1, Package 2: Buildings, Tender No. AE/001/2019-20/HQ/W/39**".

9. A combined Site visit and Pre-tender meeting will be held on **23rd March 2020**, at **the Regional Manager's Office, TANROADS, Dodoma**. The site visit will commence at 09:00 hours local time.

10. Late Bids, Portion of Bids, Electronic Bids, Bids not received, Bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
