EXPRESSION OF INTEREST FOR PROVISION OF EARLY CIVIL WORKS - REF. 612 503

TOTAL East Africa Midstream B.V. an oil and gas company, invites experienced and reputable contractors to express their interest to perform the Early Civil Works in Tanzania for the East African Crude Oil Pipeline (EACOP) Project.

The EACOP Project development involves the engineering, construction, operation and maintenance of a buried insulated oil export pipeline crossing Uganda and Tanzania with an electrical heat tracing system, associated above ground facilities and marine storage terminal in Chongoleani, near Tanga Port in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE

The Early Civil Work activities will be undertaken at several construction sites in the KAGERA, GEITA, TABORA, SINGIDA, DODOMA, MANYARA, TANGA regions and includes the following scope and activities;

1. **Site preparation** (clearing, grading, cut and fill, soil replacement, drainage, fencing,...) for the Main Camps & Pipes Yards (typ. 300x500m each); Coating & Insulation Facility 500x800m; and Permanent Sites (Pumping Stations typ. 300x400m each and Pressure Reduction Stations typ. 200x200m each and the Marine Storage Terminal 500x1300m).
2. **Access Roads construction** - Temporary access roads (TAR), permanent access roads (PAR), existing road upgrades and maintenance (ERU) for an approximate total of 100km of roadways to access Main Camps & Pipes Yards and Permanent Sites. All access roads are "murrum" type roads designed in accordance with "General Specifications for Access Roads and General Site Construction" 2000, published by: The United Republic of Tanzania Ministry of Works and suited for

WB20 semi-trailer vehicle of 2.6m width and 22.4m length in accordance with AASHTO standards. ERU and PAR roadways comply with Tanzanian road class DC6; TAR roadways comply with Tanzanian road class DC7.

These construction activities are supported by other activities which are an integral part of the Early Civil Work scope, such as: management, project control, documentation and administration; field engineering; procurement activities and supply of materials.

- o Main Camp & Pipes Yards are in the following districts: Missenyi, Muleba, Chato, Bukombe, Nzega, Igunga, Singida rural, Kondoa, Kiteto, Kilindi, Handeni Town Council, Muheza.
- o Permanent sites are in the following districts: Muleba, Mbogwe, Igunga, Singida rural, Kiteto, Handeni, Tanga.

MINIMUM REQUIREMENTS

Companies expressing their interest are invited to document their request with:

- Evidence of registration in Tanzania for the above services;
- Experiences in Civil construction works; site preparation, earthwork, drainage, roads in Tanzania;
- Confirmation that they can undertake the full services scope at either one or several locations for site **preparation or access roads construction**;
- Evidence of Suitable resources availability - equipment, systems and qualified personnel; and
- Evidence of Suitable HSE and Quality policy.

Interested companies which meet the minimum requirements and have the capability to provide the above site preparation and / or access roads construction services, should express their interest in English language by sending together with the above listed documents an email to **contractor-info@eacop-proc.com** on or before 17:00 hours **East African Time (EAT), on 25th November 2020.**
