INVITATION FOR TENDERS

1. The Government of the United Republic of Tanzania has received a loan from the OPEC Fund for International Development (OPEC Fund) and the Abu Dhabi Fund for Development (ADFD) towards the cost of Upgrading of the Malagarasi - Ilunde – Uvinza Road (51.1 Km) to Bitumen standard and intends to apply part of the proceeds of this loan to cover eligible payments under the Contract for upgrading the road.
2. The Tanzania National Roads Agency (TANROADS), an agency of the Ministry of Works, Transport and Communication now invites sealed Tenders from eligible and qualified Contractors for carrying out the **Upgrading of Malagarasi - Ilunde – Uvinza Road (51.1 Km) to Bitumen standard, Tender No. AE/001/2020-21/HQ/W/13.**
3. The Works consist of the upgrading of the existing unpaved road to bitumen standard with a 6.5m wide carriageway and 1.5m wide shoulders in rural area and 2.0 m shoulders in urban areas between Malagarasi and Uvinza. The new pavement construction shall comprise 150 mm improved subgrade (G7); 150 mm improved subgrade (G15); 200 mm of cement stabilized sub-base (C1); 150 mm crushed aggregate base course (CRR) and 50 mm asphalt concrete wearing course for both carriageway and shoulders. The works also include demolition and construction of concrete pipe culverts.

4. Bidders should note that to qualify for award of the contract, they are required to meet certain minimum qualifying criteria as provided under Volume 1 – Section IX, Tender Forms – 6. Qualification Information of the Tendering Document which includes:

- (i) Experience as Prime Contractor, they should have successfully completed at least **two (2) projects** of similar nature and complexity within the last ten (10) years, each with a minimum value of **TZS 80 Billion** or its equivalent in a freely convertible currency.
- (ii) Average Annual Construction Turnover of at least **TZS 150 Billion** or its equivalent in a freely convertible currency, in the past 5 years (2015 – 2019).
- (iii) Minimum amount of liquid assets and/or credit facilities net of other contractual commitments of **TZS 20 Billion** or its equivalent in a freely convertible currency.
- (iv) Further details and complete qualification requirements are provided in the Tendering Documents.

Tenderers should also note that the works must be completed within **Twenty-Four (24) months inclusive of three (3) months of mobilization.**

5. Tendering will be conducted through the International Competitive Tendering (ICT) procedures specified in the Public Procurement Regulations, Government Notice No.446 of 2013 as amended in 2016 and is open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.

A complete set of Tendering document(s) in English and additional sets may be purchased by interested Tenderers on submission of a written application to the address given under paragraph 6 above and upon payment of a non-refundable fee of **TZS 300,000 (Tanzania Shillings Three Hundred Thousand Only)** or its equivalent in a freely convertible currency for each set, which has to be paid with reference to Government e-Payment Gateway System (GePG) – Control Number to be issued by the Accounts Section at TANROADS Headquarters.
8. All Tenders must be accompanied by a “Tender Security” in an acceptable form in the amount of **TZS 1,000,000,000.00 (Tanzania Shillings One Billion Only)** or freely convertible currencies in case of foreign Tenderers.
9. All Tenders in one original plus three copies, properly filled in, and enclosed in plain envelopes must be delivered to the address **The Secretary, TANROADS Headquarters Tender Board, Building adjacent to Julius Nyerere International Convention Centre, 10 Shaaban Robert Road/Garden Avenue, 2nd Floor, P. Tenders will be opened promptly thereafter in public and in the presence of Tenderers’ representatives who choose to attend in the opening at the **TANROADS Main Conference Room, Building adjacent to Julius Nyerere International Convention Centre, 10 Shaaban Robert Road/Garden Avenue, 2nd Floor.**
10. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
