

Expanding your business further in Hong Kong - CurrencyFair

In early 2019, CurrencyFair established its Hong Kong office as the company's Asian hub, and expects to double its sales and operations team in the city by 2020.

CurrencyFair CEO Paul Byrne "While Hong Kong is our Asian hub, it is clearly a gateway for companies who want to enter Mainland China—a huge market that received in excess of US\$61 billion in remittance payments in 2016. It would be a natural progression for us to enter this market as we expand our Asian operations."
