

**Invitation for Tenders**

1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Tanzania National e-Procurement System (TANePS) Portal ([www.taneps.go.tz](http://www.taneps.go.tz)) dated **13<sup>th</sup> December, 2019**.
2. The Government of Tanzania has set aside funds for the operation of the National Electoral Commission during the financial year **2019/2020**. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for **the Supply of Printed Ballot Papers**.
3. The National Electoral Commission now invites Tenders from eligible Suppliers for **the Supply of Printed Ballot Papers as follows**;

4. Tendering will be conducted through the International Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.
5. Interested eligible Tenderers may obtain further information and inspect the Tendering Documents through [www.taneps.go.tz](http://www.taneps.go.tz). Interested Tenderers are strongly advised to register with TANePS system operated by the Public Procurement Regulatory Authority (PPRA) of Tanzania. All registration requirements are completed online through [www.taneps.go.tz](http://www.taneps.go.tz) where Tenderers can access Training Videos that displaying how to register (local and foreign) Supplier, how to: manage your organization details, post a Clarification request, create a tender and submit tender online or offline. 6. A complete set of Tendering Document (s) in English may be purchased by interested Tenderers upon payment of non-refundable fee of **TZS. 30,000/=** or equivalent for foreign Tenderer payable through [www.taneps.go.tz](http://www.taneps.go.tz).
7. All Tenders must be accompanied by a **Tender Security of Tanzanian Shillings Two Hundred Million Only (TZS 200,000,000.00) in acceptable form** or any freely convertible currency clearly addressed to the Director of Elections, National Electoral Commission.
8. All tenders properly filled in must be delivered to the Secretary of Tender Board **electronically** using [www.taneps.go.tz](http://www.taneps.go.tz), **at or before 14:00Hours Local Time on Monday 30<sup>th</sup> March, 2020**. Tenders will be opened promptly electronically thereafter.
9. Late tenders, portion of tenders, electronic tenders in a form of email; tenders not opened during the tender opening shall not be accepted for evaluation irrespective of the circumstances.
