REQUEST FOR EXPRESSION OF INTEREST

1. Tanzania Football Federation (TFF) intends to develop a Multipurpose Commercial Complex and associated facilities at Karume Memorial Stadium under PPP Arrangements. It is expected that; this project will give our esteemed customers and business operators a high quality of services and goods to meet their demands while generating income to TFF. In order to assess the possibility of the investment, TFF intends to hire a Consultant for Carrying out Feasibility Study for Development of a Multipurpose Business Centre and its associated facilities at Karume Memorial Stadium, in the City of Dar es Salaam.
2. The purpose of this consultancy services is: (a) to define the project and project rationale investment at Karume Memorial Stadium in Dar es Salaam. (b) conducting economic study, Market study, and supply demand analysis of football stadium, 4-Star Hotel, shops around the stadium and other associated facilities. (c) Prepare Market and Sales plan (d) Estimate the likely benefits of the services in terms of usage, impact on economic, environment and other modes, etc., (iv) Make preliminary cost estimates, including operations and maintenance costs (life cycle approach). The consultant shall maintain regular consultations with the Tanzania Football Federation as well as other stakeholders as appropriate.
3. The General Secretary of TFF now invites eligible consulting firms to indicate their interest in providing the above services. Interested consultants must provide information indicating that they are qualified to perform the services i.e., *qualifications; description of similar assignments (name of assignment, name and contact address of the client, value, period); experience in similar conditions; and availability of personnel with proven skills and experience in areas related to economic evaluation of public projects and public private partnership efforts.*
Firms may associate to enhance their qualifications
4. This is not a request for proposals (RFP). After a review of the expressions of interest, a shortlist will be prepared and the short-listed consultants will be invited to submit their proposals through a letter of invitation including specific terms of reference. A consulting firm will be selected in accordance with the Consultants' Quality Based Selection (QBS) method and procedures set out in the *Tanzania Football Federation Procurement Guidelines (Selection and Employment of Consultants by TFF)*.
