PROVISION OF CONSULTANCY SERVICES FOR SUPERVISION OF ROAD WORKS – DAR ES SALAAM BUS RAPID TRANSIT (BRT) INFRASTRUCTURE – PHASE 3; LOT 1: ROAD WORKS (23.33KM); TENDER NO. AE/001/2019-20/HQ/C/57

REQUEST FOR EXPRESSIONS OF INTEREST (CONSULTING SERVICES – FIRMS SELECTION)

The Government of the United Republic of Tanzania has received financing from the World Bank toward the cost of the Dar es Salaam Urban Transport Improvement Project (DUTP) and intends to apply a portion of the proceeds for Consultancy Services for Supervision of Road Works – Dar es Salaam Bus Rapid Transit (BRT) Infrastructure – Phase 3: Lot 1: Roadworks (23.33Km).

The Dar es Salaam BRT Phase 3 road infrastructure corridor starts at Posta within the Central Business District (CBD) and passes along Azikiwe/Maktaba Street [0.95 Km], Bibi-Titi Street and Nyerere Road past Julius Nyerere International Airport (JNIA) to Gongo la Mboto area [17.92Km]. Another branch starts at the Kariakoo BRT Terminal along Uhuru Street to Buguruni and Nelson Mandela Road and joins Nyerere Road at the TAZARA junction [4.46Km]. The corridor with two mixed traffic lanes shall accommodate one (1) Buses Depot (at Gongo la Mboto), one (1) Buses Terminal (at Kariakoo), three (3) Feeder Stations (at Jet Club, Banana and Buguruni-Rozana area), thirty-two (32) Bus Stations and five (5) pedestrian crossing bridges at the Kisutu Market, Buguruni-Rozana Feeder Terminal, JNIA Terminal, Banana and at Gongo la Mboto. The Park-and-Ride facilities for private car owners are planned to be supported near the Jet Club Feeder Transfer Station and at Gongo la Mboto Buses Terminal.

The consulting services (*“the Services”*) include the supervision of construction of the respective roads infrastructure based on the approved designs within a period of twenty (20) calendar-months and subsequent management of the facility under the Defect Liability Period extending for subsequent twelve (12) calendar-months. Within this context, the Consultant shall be entrusted with the following responsibilities:

1. carrying out supervision of civil works and ensure compliance with the approved design, drawings, specifications, conditions of contract, approved works programmes and sound engineering practice;
2. prepare comprehensive reports in each six (6) months' cycle on the Environmental and Social Management Plans (ESMP) and provide annual reports on measures adopted for the safety of the Project roads, sensitization of local population on HIV/AIDS, STI, TB and Gender issues;
3. review of the proposed traffic deviations during construction period for the purpose of ensuring that the proposed traffic arrangement results minimal disruption to the public;
4. preparation of the Final Completion Report (FCR) and “as-built-drawings” for all completed civil works along the Project Corridor; and,
5. Carry out supervision of activities during the Defects Notification Period.

Tanzania National Roads Agency (TANROADS), an Executive Agency of the Ministry of Works, Transport and Communication now invites eligible consulting firms (*“Consultants”*) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are: eligibility, experience on similar assignments in the last ten (10) years, experience of undertaking assignments under similar conditions and availability of appropriate skills among staff in relation to the assignment in context.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, revised July 2014 (*“Consultant Guidelines”*), setting forth the World Bank's policy on Conflict of Interest.

Consultants may associate with other firms in the form of a Joint Venture or Sub-consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
