BUILDING ON PLOT NO. 1, BLOCK "D" – NCC AREA, DODOMA**

1. This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in the Daily News and Habari Leo of Thursday, 18<sup>th</sup> September 2019.
2. The Government of the United Republic of Tanzania has set aside funds towards the cost of the construction of Judiciary Building on Plot No. 1, Block "D" at NCC Area - Dodoma and intends to apply this fund for payments of the contract for the construction of Judiciary Building. The Judiciary of Tanzania intends to pre-qualify contractors and/or firms for construction of Judiciary Building on above mentioned plot.
3. The project consists of the following Works: -
  - Construction of Nine Floors of Star-shaped building with Ground Floor, Elevated Ground Floor and other Seven floors (G+EG+6F+TF). The overall gross floor area of the building is approximated to be 58,710 m<sup>2</sup>.
  - Associated Building Engineering Services installations that is, Electrical, Fire Detection & Alarm System, ICT & Security System, Air Conditioning & Ventilation System, Plumbing & Fire fighting and Lifts Installation.
  - Associated Auxiliary Buildings, External Works, Parking Areas, Walkways, Soft Landscaping and Boundary Wall.
4. The Judiciary of Tanzania now invites bids from qualified Building Contractors registered in Class One (1) Category from eligible source Countries to apply for pre-qualification.
5. It is expected that, invitation to tender will be made in April, 2020.
6. Pre-qualification will be conducted through the procedures specified in Regulation 119 of the Public Procurement Regulations, – Government Notice 446 of 2013, amendments No.333 of 2016 and is open to all applicants as defined in the Regulations.
