On setting import customs duty rates Common Customs Tariff of the Eurasian Economic Union for certain types of goods imported into the customs territory of the Eurasian Economic Union in order to ensure the sustainability of the economies of the member States of the Eurasian Economic Union

In accordance with Articles 42 and 45 of the Treaty on the Eurasian Economic Union of May 29, 2014 and paragraphs 16 and 18 of the Regulations on the Eurasian Economic Commission (Annex No. 1 to the Treaty on the Eurasian Economic Union of May 29, 2014), in order to implement the order of the Council of the Eurasian Economic Commission of March 17, 2022 No. 12 and ensuring the sustainability of the economies of the member States of the Eurasian Economic Union The Board of the Eurasian Economic Commission decided:

1. Establish import customs duty rates of the Common Customs Tariff of the Eurasian Economic Union approved by the Government of the Russian Federation.By Decision of the Council of the Eurasian Economic Commission.

2. Add notes to the Common Customs Tariff of the Eurasian Economic Union approved by the Government of the Russian Federation. Decision of the Council of the Eurasian Economic Commission No. 80 of September 14, 2021, with Notes 63C-66C to read as follows:

"63C) The rate of import customs duty in the amount of 0 (zero) % of the customs value is applied from 28.03.2022 to 30.09.2022 inclusive.

^{64C)} The rate of import customs duty in the amount of 0 (zero) % of the customs value is applied from 28.03.2022 to 30.09.2022 inclusive, and from 01.10.2022-in the amount of 8 % of the customs value in respect of goods imported into the Russian Federation.

^{65C)} The rate of import customs duty in the amount of 0 (zero) % of the customs value is applied from 28.03.2022 to 30.09.2022 inclusive, and from 01.10.2022-in the amount of 7.5 % of the customs value in respect of goods imported into the Russian Federation.

66C) The rate of import customs duty in the amount of 0 (zero) % of the customs value is applied from 28.03.2022 to 30.09.2022 inclusive, in the amount of 12% of the customs value-from 01.10.2022 to 28.02.2023 inclusive.".

3. This Decision comes into force after 10 calendar days from the date of its official publication and applies to legal relations that have arisen since March 28, 2022.
